- 1) Place the base on a test platform with blocks under base arms.
- 2) A force of 11,120N (2,500 lbf) shall be applied for 1 minute.
- 3) Remove the force.
- 4) Apply a second force of 11,120N (2,500 lbf) for 1 minute.
- 5) Remove the load and evaluate the product in accordance with the acceptance level Section 7.5.

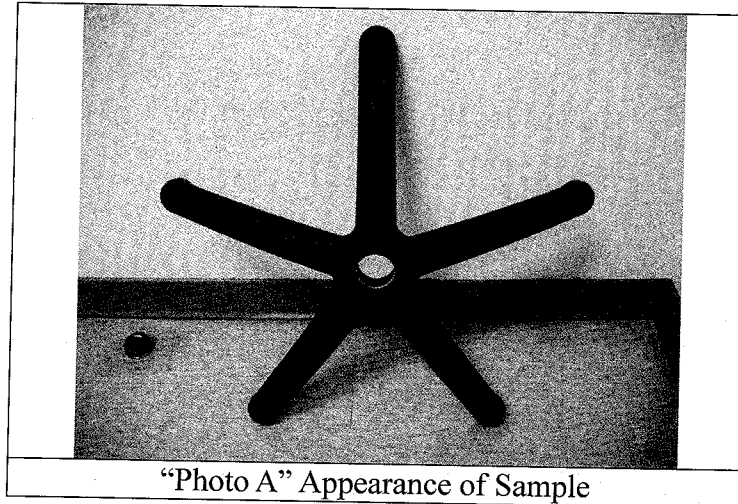

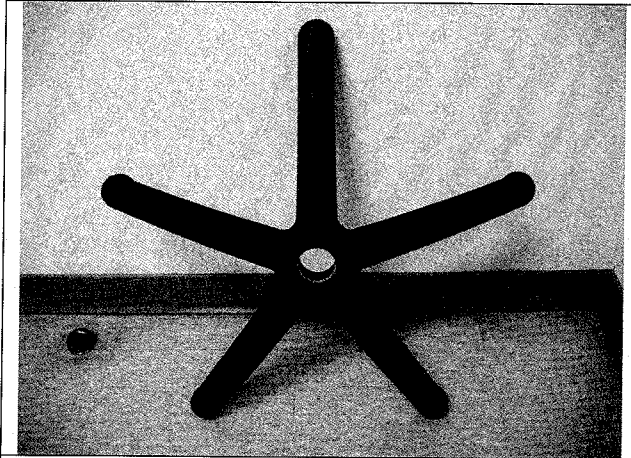
