- 2) Apply a 2500lbf (11100N) load for 1 minute and remove, record any findings.
- 3) Reapply the 2500lbf (11100N) load and maintain until deflection is reasonably stabilized, record any finding.
- 4) Increase the load until the chair base is broken. (Requested by the client)



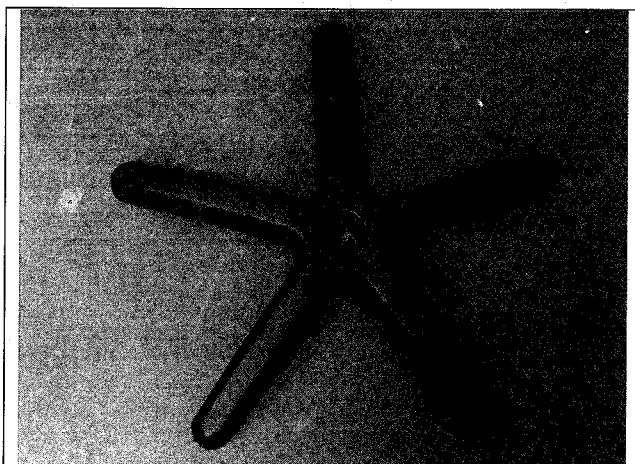
